

All volunteers and homestay parents with the Chilliwack School District are required to complete a Vulnerable Police Information Check (PIC) through the Criminal Records Review Program (CRRP). PIC's are effective for 5 years and there is no cost associated with the online form.

In accordance with the Criminal Records Review Act, Applicants for volunteering, section 24.4 (1) Before working with children or working with vulnerable adults as a volunteer with a registered specified organization, an individual must provide to the registered specified organization a criminal record check authorization or a criminal record check verification authorization, as applicable.

Please visit the link below to complete your Police Information Check (PIC). The access code is also required when proceeding with the online submission. In order to assist in successful completion, please read the guide below and have all your documents ready before clicking on the link.


